





(Each red circle indicates a 5-mile radius) The area south of MJ lacks adequate service




WEMA "hot spot" locations in MJ city (includes vehicle accidents)



MJ's options if WEMA is pulled from current two stations (E. Hill St. & Belinda Pkwy.)

- Do nothing, continue with WEMA servicing the city from two new locations that are still within city limits, but further out
- Create our own ambulance service, which is costly
- Private ambulance service (3) at no cost to taxpayer or city outside of billing a patient's insurance company
 - Residents are not taxed twice
 - Uninsured would be transported regardless and be billed at rates set by Medicare
- Equip FDMJ vehicles with ALS equipment (Advanced Life Support), but would not have capability to transport. Currently FDMJ is equipped with AEMT (Advanced Emergency Medical Technicians)

If we choose a private ambulance service that only services the city, would time be lost?

- No time would be lost, 3-5 minutes would be saved because the call would not be transferred from Wilson 911 to another dispatch as it is now with WEMA
- The caller would talk to one dispatcher and tell the story one time only, then dispatch would send directly to FDMJ
- Locations would be predetermined on a CAD system so no research would be necessary to locate the patient

Qualifications of FDMJ for medical calls

- All members of FDMJ hold a medical licensure and are first responders at the Advanced EMT level already.
- All FDMJ vehicles are currently capable of providing AEMT which includes IV therapy, defibrillation, bleeding control, splinting, and similar treatments, but does not transport.



What do the numbers say about the future?

- Currently we are at an all-time high for overlapping calls
- As of August 2021, MJ has had 3,233 calls since August 2020
- Out of those, 1,563 have been overlapping (more than one at a time)
- Resulting in 48.35% of the time
- This is an increase of 20% since December 2020 (8 months)

Future Numbers (Cont'd)

- We are on pace for 3,300 calls by the end of December 2021
- FDMJ five-year estimate is over 5,000 calls by 2026
- Again, as of December 2020, MJ was at 2,896 calls according to

Starting Point for Discussion

As a compromise in lieu of the \$60k rent:

- 1. The ambulances stay in the CoMJ Fire Stations (E. Hill St. & Belinda Pkwy.)
- 2. FDMJ will receive the required CEU annual training at no charge
- 3. FDMJ will receive any/all medical supplies needed and utilized at no charge
- 4. Since we are a year out from completed construction, data and discussions will be studied and an open dialog will begin for the 3rd ambulance to be housed in the new station

Items for debate in discussions centering on the third ambulance at the North District FDMJ Station:

- 1. No rent for housing the unit & crew
- 2. AUTOMATIC AID (can contribute to lower ISO rating for the county constituents 7 automatically provide a ladder truck & crew saving the county >\$1million) in the urban growth boundary and/or extended zone as to be negotiated by the MJ City Mayor & WC Mayor
- 3. Proper space for WEMA Rescue Boat (5 minutes from Shutes Branch & Cedar Creek)
